### NOTIFICATION

MAHARASHTRA UNAIDED PRIVATE PROFESSIONAL EDUCATIONAL INSTITUTIONS (REGULATION OF ADMISSIONS AND FEES) ACT, 2015.

No. MED-1016/C.R. 69/16/Edu-2.— In exercise of the powers conferred by section 23 of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015 (Mah. XXVIII of 2015), the Government of Maharashtra hereby makes the following rules to amend the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admission to the Full Time Professional Undergraduate Ayurved, Unani, Homeopathy, Physiotherapy, Occupational Therapy, Speech Therapy, Prosthetic and Orthotics and B.Sc. Nursing Courses) Rules, 2016 regulating the admissions to the First Year of the Full Time Professional undergraduate Ayurved, Unani, Homeopathy, Physiotherapy, Occupational Therapy, Speech Therapy, Prosthetic and Orthotics and B.Sc. Nursing Courses in the Unaided Private Professional Educational Institutions in the State of Maharashtra, namely :—

1. These rules may be called the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admission to the Full Time Professional Undergraduate Ayurved, Unani, Homeopathy,

Physiotherapy, Occupational Therapy, Speech Therapy, Prosthetic and Orthotics and B.Sc. Nursing Courses) (Second Amendment) Rules, 2020.

2. In rule 5 of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admission to the Full Time Professional Undergraduate Ayurved, Unani, Homeopathy, Physiotherapy, Occupational Therapy, Speech Therapy, Prosthetic and Orthotics and B.Sc. Nursing Courses) Rules, 2016 (hereinafter referred to as "the principal Rules"), after sub-rule (3), following shall be added, namely :---

"(4) *OCI Candidature*.--- The candidate who fulfills the conditions as defined in clause (p) of sub-rule (1) of rule 2 shall be eligible under this Category."

3. In rule 8 of the principal Rules, for sub-rule (3), following shall be substituted :---

"(3) *Institutional Quota seats*.--- The institution can admit eligible candidates against 15 per cent of the sanctioned intake, as per the Schedule, on All India Basis, including Non- Resident Indians and Overseas Citizens of India, who had appeared for the National Eligibility-cum-Entrance Test and declared eligible for admission to undergraduate Ayurved, Unani, Homeopathy, Physiotherapy, Occupational Therapy, Speech Therapy, Prosthetic and Orthotics and B.Sc. Nursing Courses, in accordance with *inter-se-merit* amongst candidates, who apply for institutional quota seats, subject to the approval by the Admission Regulating Authority. "

4. In Schedule appended to the principal Rules, in column (4), for the words "Including NRI Quota" the words "Including NRI and OCI Quota" shall be substituted.
